- Voted on new board positions
 - i. Motion by Corey Stout to appoint Josh Weerda as VP, seconded by Jason Gustafson. Passed with 4 ayes 0 nays.
 - ii. Motion by Dustin Kaap to reappoint Brad Bull as Treasurer, seconded by Corey Stout. Passed with 4 ayes 0 nays.
 - iii. Motion by Corey Stout to reappoint Jason Gustafson as President, seconded by Brad Bull. Passed with 4 ayes 0 nays.
 - iv. Motion by Jason Gustafson to reappoint Dustin Kaap as Secretary, seconded by Brad Bull. Passed with 4 ayes 0 nays.
- Discussed Jr. Tackle player equipment status.
 - i. Helmets and shoulder pads have not been replaced on a rotation program so most of this equipment needs replacement now. Greg Carlson proposed WPD advance \$35,000 now to replace 100 helmets and 100 shoulder pads, and said the plan is for the Jr Tackle program to return this amount to WPD in 2022 through restructuring the fee collection and fundraising program. The plan is to increase Jr Tackle fees from \$120/year to \$300-350 to be in line with what other schools charge, and to fundraise another \$10,000-15,000 in 2022.
 - ii. The plan is for Jr Tackle to be budget neutral or have a net income going forward, and for player equipment to be on a rotating schedule.
- Motion by Brad Bull to spend \$35,000 to purchase 100 new helmets and 100 new shoulder pads for Jr Tackel. Motion seconded by Jason Gustafson. Roll call with Jason Gustafson approved, Brad Bull - approved, Corey Stout - approved, and Dustin Kaap - approved.
- Discussed tennis court resurfacing but decided to focus on outdoor bathrooms in 2022. Further discussion is needed regarding tennis court crack sealing.
